### Approach

To begin the review, Panacea will import your current charge description master ("CDM"), supply item master, pharmacy master and related service utilization files into its ChargeAssist® module to benchmark against Medicare and AMA reporting guidelines.

Upon receipt of the files, your data is imported into our systems. Panacea consultants categorize each line item into groups that align with industry best-practice classifications, including determination of separately billable supplies, bundled items and non-chargeable items and equipment.

The audit will focus on:

- Healthcare Common Procedure Coding System (HCPCS) / Current Procedural Terminology (CPT) code and claim-form Revenue Code correlations
- Service description and HCPCS/CPT procedure code correlations
- Identification of obsolete, invalid or erroneous charge codes
- Comparison of hospital fees to Medicare ambulatory payment classifications (APCs) and other applicable fee schedule amounts
- Identification of missing Add-On codes
- Identification of potential charge capture gaps
- Identification of non-compliant charge practices
- Evaluate charge capture practices

Pharmaceutical services will be processed through ChargeAssist® to identify any coding or compliance issues with HCPCS and/or Revenue code assignments at the NDC level.

After completing the steps listed above, the Panacea consulting team will conduct applicable remote interviews with hospital departments/clinical staff responsible for coding, billing and/or chargemaster maintenance functions. During the remote interviews, Panacea will review our initial findings from the preliminary chargemaster review to verify our initial findings, provide concurrent recommendations for improvement and to develop implementation strategies to improve regulatory compliance and revenue capture.
